





CONSTITUTIONAL AMENDMENT

HJR 51 (House Joint Resolution) ARTICLE VI, SECTION 4

VOTING RIGHTS OF FELONS.—The State Constitution currently prohibits a person who was convicted of a felony from voting until the person's civil rights are restored. This amendment will prohibit a person convicted of a felony from voting only until completion of all sentences imposed and expiration or completion of all conditions of supervision, if any, for the felony conviction.

Legislative Report...from Darrin Brooks

- ABATE of Florida; Inc. did very well in the November elections. Our supported candidates for Attorney General, Agriculture Commissioner, Chief Financial Officer, and Governor all won.
- In the State Senate, ABATE supported candidates won all but two seats. The Sen. from Alachua area that stopped our stiffer penalties bill did win re-election.
-
- Sen. Greg Evers, ABATE member and big supporter of motorcyclist has been selected as Chairman of the Criminal Justice Committee and Vice Chairman of the Transportation Committee. These are two big committees that our “stiffer penalties” bill must pass through.
-
- On the House side, in the 83 races that ABATE supported a candidate, we won 67 of them.
-
- David Rivera, Gator Alley member, was elected to the US Congress.
-
-
- NHTSA (National Highway Traffic Safety Administration) is still pursuing the motorcycle only “safety” checks.
-
- NTSB (National Transportation Safety Board) is calling for all States to adopt a motorcycle helmet law.
-
- New study in Florida shows that in 61% of the motor vehicle vs. motorcycle collisions, the motor vehicle was at fault. The number one reason given was that the vehicle driving did not see the motorcycle.

I have an amazing comity comprised of several current presidents a past president and some new highly motivated people. At some point soon Angel and myself will be meeting with ABATE of Georgia to find out the pitfalls that they have experienced firsthand. We will also be trying to meet with ABATE of Indiana. I would be happy to receive contact information for any other state with a JR ABATE. Please reserve your ideas for a later date this is just an exploratory comity at this time. Ideas and concepts will be well received at in the future.







Whatsoever you write, or paint, or play, or sing, or build, no one will strive to surpass, or to slander you, unless you work be stamped with the deal of genius. Long, long after a great work or a good work has been done, those who are envious or disappointed continue to cry out that it cannot be done. Spiteful little voiced in the domain of art were raised against our own Whistler as a mountebank, long after the big world had acclaimed him its greatest artistic genius. Multitudes flocked to Bayreuth to worship at the musical shrine of Wagner, while the little group of those whom he had dethroned and displaced argues angrily that he was no musician at all. The little world continued to protest that Fulton could never build a steamboat, while the big world flocked to the river banks to see his boat steam past. The leader is assailed because he is a leader and the effort to equal him is merely added proof of that leadership. Failing to equal or to excel, the follower seeks to depreciate and to destroy, but only confirms once more the superiority of that which he strives to supplant. There is nothing new in this. It is as old as the world and as old as the house. Envy, fear, greed, ambition and the desire to surpass and it avails nothing. If the leader truly leads, he remains, the leader. Master-port, master-painter, master-workman, each in his turn is assailed and each itself known, no matter the ages. That which is food or great makes itself known, no matter how loud the clamor of denial. That which deserves to live – lives.






